This gives the user superior live video performance, while using minimal USB and CPU resources.

Installation

PC Installation:

- 1) Put the iREZ CD-Rom into your computer.
- 2) If running Windows 98 (others please skip to step 3), click start, click run, and type `x:\windows\windows98\setup.exe` (where X: is the letter of your CD-Rom).
- 3) Plug the USB Live! New Edition into your computer via your USB port. (Windows 98 users may not need to follow the rest of these instructions).
- 4) The "add new hardware wizard" should appear. Place a check mark in the CD-ROM checkbox. Windows ME users: specify the location of the drivers as `x:\windows\windowsme\` (where X: is the letter of your CD-Rom).
- 5) Click on "Continue Anyway" if a Digital Signature warning appears.
- 6) Connect your VCR, camcorder, etc to the USB Live! New Edition.
- 7) With the iREZ CD still inserted, open the Video Impressions folder. Open the application titled "Setup". Follow the on screen instructions.

Mac Installation:

- 1) Put the iREZ CD-Rom into your computer.
- 2) Double click the appropriate folder for your operating system (Mac OS 9 or OS X).
- 3) Double click the installer for the USB Live! New Edition.
- 4) Follow the instructions in the installer.
- 5) Plug your USB Live! New Edition into your computer via the USB port, if you have not already.
- 6) Connect your VCR, camcorder, etc to the USB Live! New Edition.
